Coronavirus Updates

We completed booster clinics for the Pfizer and Moderna COVID-19 vaccines. There are no active cases of COVID-19 in residents or employees.

Assisted Living will change quarantine protocol effective Monday, November 8. Westminster Canterbury residents will no longer be required to quarantine when moving to Assisted Living. Booster clinics have successfully been conducted in Assisted Living. External admissions will be required to quarantine until their PCR test returns negative. They will have a rapid done at the time of admission and a PCR test will be done three days after their admission date.

For residents returning from a leave of absence, only unvaccinated residents will be required to quarantine upon return until a negative PCR is obtained. The PCR test will be done three days after return from leave of absence.

Any resident who exhibits symptoms of COVID-19 will continue to quarantine until negative PCR results return, regardless of vaccination status.

Resident Satisfaction Survey Reminder

Residents are reminded to complete the Resident Satisfaction survey. These are due to Holleran Consulting on November 15. Written surveys were placed in Independent Living boxes on November 1. The Promenade renovation and expansion is well underway. We look forward to its reopening next year. During this special season of the year, many are considering ways to make the biggest difference through your charitable gifts. Westminster Canterbury Foundation's *Vibrant Vision* campaign includes priorities for People, Places, Programs and Promises.

We need your help to reach this goal by December 31.

We also support seniors-in-need in greater Richmond through Fellowship Outreach efforts with partners in the community, such as our ramp building volunteer projects with project:HOMES and free health screenings and social engagement programming in partnership with Senior Connections.

Your support of the Foundation also helps with Places. Your gifts supported \$4 million toward the new Spiritual Center. Next, we look forward to a new Vital Living Center that will be built as part of the *Vibrancy!* expansion. Our vision for healthy aging brings healthcare offerings and wellness together to nurture each person's unique independence at whatever stage of life they are in. The Corporation is covering the construction through existing available funds and the sale of new residences. Generous gifts to *Vibrant Vision* will help bring the Vital Living Center to life through specialty fitness equipment, technology, additional instructors and staff, education and other resources.

Many Programs are supported by your gifts to the Foundation – Healthcare Excellence, wonderful performances in the Sara Belle November Theater and throughout our campus and gardens, Studio Arts programs, the Child Development Center, Pastoral Care, Memory Support and Innovation.

One area that can get tricky this time of year is the difference between Westminster Canterbury Foundation's W·E·A·V·E program and the resident-run Employee Christmas Fund. Bev Beck is here from the ECF Committee to help us clear up that confusion. Both efforts are very important and so helpful to our wonderful employees.

Many of you support the Foundation's W·E·A·V·E Program for workforce-education-assistance-volunteerism-engagement. This program provides scholarships to help employees improve their skills, education and careers. 19 employees received \$30,000 in scholarships last year. It helps with emergency assistance when employees need it most. 55 employees have sought emergency financial assistance, usually due to family illness or a spouse losing a job. W·E·A·V·E also supports our employees as they volunteer in greater Richmond and helps engage them in our community. A gift to the Foundation for W·E·A·V·E or any of these other areas is a tax-deductible contribution. This is different from the Employee Christmas Fund, which is a gift to the employees that is not handled through the Foundation and is not tax-deductible.

Courtyard Elevator Project

For years we have received valid concerns from residents living in the eastern part of the Courtyard about the distance a resident must travel from their parked vehicle in the parking garage to their apartment, especially when carrying groceries and other personal items. After studying the options, we proposed and received approval from the Finance-Property Committee to install elevators on the far eastern end of the Courtyard Apartments. There will be one passenger elevator for each wing of the east Courtyard from the parking garage level to the fourth floor.

The look of the addition that will house the elevator and the vestibule will blend in with the existing architecture and rooflines. Last week we met with Courtyard residents to review the schematic design. It was received with overwhelming support. Five bidders proposed a design-build solution for the elevator towers. We selected Emerald Construction and design partner Moseley Architects. The project is expected to take six months from groundbreaking. We hope to start this project in late spring.
